Moscicki motioned to approve the Treasurer's report as given, 2<sup>nd</sup> by Beane, all voted in favor.

### **Meeting Minutes:**

Minutes for the Feb 12<sup>th</sup> meeting and Feb 13<sup>th</sup> Budget Hearing were reviewed. Moscicki motioned to approve all the minutes as written, 2<sup>nd</sup> by Beane, all voted in favor.

#### Committee/Department Reports & Needs:

Clark updated the Board on Highway Dept matters on Tom Smith's behalf. The weight limit restrictions were posted on Lyman's roads as of Feb 26<sup>th</sup>. A purchase order was approved for Tac-2 Communications for \$1,009.56 to install a radio in the grader that was previously used in the Town Hall. The NH Dept of Transportation is developing an Oversize/Overweight permitting software system. The Selectmen agree with Tom that the Town would not benefit from participating in this project. \* Clark will check with the road crew to determine a date for the 1<sup>st</sup> Quarter 2018 Safety Committee Meeting. \* Beane and/or Moscicki will be on hand at the Town Hall during Town Meeting polling hours.
