SELECTMEN'S MINUTES

April 27, 2020

Present by Roll Call: Bruce Beane, Jim Trudell (with Donna Trudell in the room), Wendy Ho-Sing-Loy, Donna Clark-AA, Tabbetha Shosa-Office Assistant, Tom Smith-Road Agent

Chairman Trudell called the meeting to order at 6:00 pm.

Manifests & Invoices:

The manifests for 04/20/20, 04/24/20 and 04/27/20 were authorized and new invoices for future payment were reviewed and initialed by the Selectmen individually earlier in the day.

Treasurer's Report:

The Treasurer's Report was read showing a balance of \$162,382.40 in the WGSB checking account and \$55,903.82 in the WGSB Insured Cash Sweep (ICS) account. Trudell motioned to approve the Treasurer's report as given, 2nd by Ho-Sing-Loy, all voted in favor by roll call vote: Trudell-Aye, Beane-Aye, Ho-Sing-Loy-Aye. * Treasurer Celine Presby requested quotes for interest rates on a \$600,000 Tax Anticipation Note from various banks and Woodsville Guaranty Savings Bank came in the lowest at 1.5% per annum. Trudell motioned to approve the \$600,000 TAN in the form of a line of credit with WGSB, 2nd by Ho-Sing-Loy, all voted in favor by roll call vote: Trudell-Aye, Beane-Aye, Ho-Sing-Loy-Aye. The loan agreement was signed.

Meeting Minutes:

Minutes for the Apr 13th meeting were reviewed. Beane motioned to approve the minutes as written, 2nd by Ho-Sing-Loy, all voted in favor by roll call vote: Trudell-Aye, Beane-Aye, Ho-Sing-Loy-Aye.

Committee/Department Reports & Needs:

Road Agent Tom Smith joined the meeting via Zoom at 6:00 pm to discuss Highway Dept matters. The replacement 2020 10-wheeler is being worked on at Tenco but no delivery date has been given. Beane reported that he has a lead on a gently-used Case loader with attachments that has only been used for 111 hours that may be available for a good price. Beane and Tom will do more research and report back. * The group also talked about tightening up on spending where possible in light of the COVID-19 pandemic. Money received annually from the State in the form of shared Meals & Rooms tax and Highway Block Grant funds will likely be much less than anticipated. Local revenues such as motor vehicle registrations and property taxes may also be impacted. Highway department areas that could see spending cuts include temporary help, highways & streets, repairs & maintenance, winter sand and garage expenses. Other budgets being looked at for cutbacks include financial administration, town attorney, planning board and cemeteries. Beane will advise Littleton Monument

Company that annual cemetery stone repair work will be put on hold for this year. More discussion will follow at the next meeting.

The Selectmen reviewed and signed the 2021 Reappointment Form for Lyman's Forest Fire Warden & Deputies. Brett Presby will remain the Town's Forest Fire Warden and Richard Hubbard, Wanda Hubbard, Celine Presby and Scott Santy will continue as Deputy Wardens. Thank you to all of them.

Trudell motioned to adjourn the meeting at 6:45 pm, 2nd by Ho-Sing-Loy, all voted in favor by roll call vote: Trudell-Aye, Beane-Aye, Ho-Sing-Loy-Aye.
