- 9. All-seasons safe sight distance is defined as a line which encounters no visual obstruction between 2 points, each at a height of 3'9" above road surface. Minimum sight distance on a posted 25 mph road is 200' in either direction, and 300' minimum on a 35 mph road.
- 10. Grade of driveway will be level for a distance of 20 feet from edge of roadway.
- 11. Grade of driveway not to exceed 10%.
- 12. Driveway entrance not to exceed 30 degrees from a right angle at the roadway.
- 13. Minimum driveway entrance width 20 feet at travel surface of road.
- 14. Minimum 15" wide, 20 foot long culvert must be installed if the Road Agent feels that a culvert is required. Private driveway connections, including culverts, remain the continuing responsibility of the landowner, even those located in the right-of-way. (If any driveway connection threatens the integrity of the highway due to plugged culverts, erosion, silitation, etc., the Board will order the owner to repair it, failing which the Town will do the repair and charge the costs to the owner.)
- 15. The driveway must be accessible to emergency vehicles.
- 16. The proposed driveway entrance must be clearly flagged on both sides at edge of road.
- 17. Road side boundary markers (pins, stone walls, etc) must also be clearly flagged.
- 18. Include a property map showing the following information:

- a) Boundary markers at the edge of the road, distances from each corner to the proposed driveway and the width of the proposed driveway. See the attached template for required measurements.
- b) Distance visibility in both directions from center of proposed driveway.
